Permits for Transportation, Storage and Use

This list is a general summary of the Special Effects activities that require a permit, the amounts of materials that trigger a permit and the associated costs as of 2.1.15. This list is not definitive and does not supersede NY City Fire Code, NYC Administrative Code, NY State Explosives Laws, Federal Laws governing these materials or any of the written or oral guidelines issued by the FDNY Explosives Unit or the Mayor's Office of Film, Theater & Broadcasting or any other AHJ.

NOTE: All permits issued by FDNY Explosives Unit require a site inspection prior to issuance

Colored Smoke Cookies, smoke powder or smoke sticks Interior	Any quantity of pyrotechnic or lit smoke	Smoke or smoke like dust effects or smoldering smoke compound to make smoke including non-toxic colored in NYC within a building	FDNY Explosives Unit permit and inspection at \$210 per location plus: • an E-18 or E-19 to supervise the effect if required by FDNY Inspector

Storage of Pyrotechnic Materials flammable gas or flammable liquids	Any	Storage of Low Explosives, Flammable Solids, Articles Pyrotechnic, Flammable Gas or Flammable Liquids in an FDNY approved magazine, cage or bunker at a stage, theater or on location	FDNY Explosives Unit permit at \$210 plus sprinklers and smoke detector if indoors

Quantity Conversions:

Dewar of liquid carbon dioxide (LCO2) = 180 liters or 47.6 gallons

Dewar of Liquid Nitrogen (LN2) = 160 Liters or 42.3 gallons

Tank of CO2 50 lbs. = 18 liters or 4.75 gallons
